## Foundation Overview

Zo Inspiration Foundation was founded on June 7, 2020, during the height of the Covid-19 pandemic. It began when our Founder reached out to his close friends, inviting them to form a dedicated group, creating a WhatsApp Group later known as the **'Core Team'.** They began reaching out across Aizawl and villages in Mizoram offering support to those in need.

During Covid-19 pandemic, we distributed rice, food, medicine and financial assistance; generously donated by kindhearted people to those in need.

As time passed, starting in 2022, we shifted our focus entirely to social work and ceased publishing **non-aid-related** content on YouTube. From that point forward, we have dedicated ourselves fully to helping those in need across Aizawl, its surrounding areas and various villages throughout Mizoram.

To align with legal requirements, we took steps to become more organized and structured. We are now a **registered foundation**, officially recognized by the government, with an established office and a formally appointed Board of Directors. Under their guidance and leadership, the foundation has taken steps with great purpose.

We are truly thankful that the YouTube channel started by our Founder has grown into a meaningful and caring bridge, bringing together people who are in need with those kind and generous individuals who are willing and eager to offer their help.

As workers dedicated to providing aid through public funding and handling financial resources, we must exercise great care and continually learn through experience.

We often encountered things we were unfamiliar with, but we sought knowledge through books and the internet, learning as we went. Even now, we continue to grow and learn every day.

## Distinguished Awards

Our aid work and initiatives have found a place in people's hearts beyond anything we could have hoped for. By God's grace and through the generosity of the public, we are honored to have received four distinguished awards.



### Social Media

Social media has become one of our main platforms for carrying out and sharing our aid work. Through this channel, we have been able to showcase our various initiatives, reaching far more people than we have ever anticipated. By god's grace, our efforts have touched many hearts and we have been blessed with a growing number of followers who support and believe in our mission.



## Office Development Story

The Zo Inspiration Foundation opened its office for the first time on July 1, 2023 at Chawngziki Building, c/o Dr. Lalremtluangi, Ramhlun Venglai with just three staff members. The opening ceremony was inaugurated by Rev. Dr. H.Vanlalruata, who was the Registrar of ATC at the time, and a prayer for God's blessing and guidance was offered by CO Maj. Jerry Lalrozama, presiding officer of Ramhlun Corps.

Our Office Administration faced challenges in the initial stages due to our limited knowledge of social work and administrative practices. We started by arranging basic seating for staff, then moved on to acquiring computers; only to realize we were not sure how to use them effectively. With help from others, we learned to organize files and manage tasks on the go. We have also visited other offices to better understand their filing systems and improve our own.

Gradually, we have learned step by step. Even in places where we had no prior connections, God paved a way for us. Though we have stumbled at times, we have continued to move forward to this day.

Due to the heavy rain at the end of

2024, our office was flooded, creating a significant challenge for us. With no immediate solution available and the space becoming increasingly cramped, we were left with no choice but to begin searching for a new office location.

After a long search, we finally found a suitable space at Lalthuama Building, c/o Lalkailiana, Chanmari, Aizawl. Although they had received several offers from others, they chose to rent it to us at a rate even lower than what was offered by others. We are truly grateful for their generosity.

Although it was the end of the year, we felt it was best to relocate without delay. With a sense of reluctance, we took down our signboard and prepared for the move. We hired **DJ Packers & Movers to begin the relocation on September 23, 2024 at 8:00 p.m.** 

The Pickup truck transported our belongings in two trips and we completed the move around midnight after wrapping everything up. However, with much remaining to be organized, we continued working the next morning and spent nearly a full week arranging and setting up the new office.

Our new office at Chanmari, Aizawl was officially inaugurated on October 5, 2024 by Rev. B. Sangthanga, Ramhlun North. Alongside our Board Members, Advisers and Executive Members, we were honored to be joined by many who have shown their support and love for our organization. Representatives from local YMA, MHIP, MUP and leaders from various churches also took part in the occasion, making it a joyful and memorable event.

#### **Office Timing:**

Our Office hours are from 9:30 a.m. to 5:00 a.m. during the summer and from 9:00 a.m. to 4:30 p.m. during the winter.

#### Staffs Devotion :

Every Monday at 9:30 a.m., we hold a Staff Devotion session. This time is dedicated for motivational speeches as well as praise and worships. We invite our Board Members and Advisor to share words of encouragement and we also welcome guest speakers from outside the organization who would inspire and uplift our staff.



#### Number of Staff :

As of the time this report is prepared, the foundation has a total of 10 staff members, comprising of 3 regular staff and 7 contract staff.

Our new office initially had only two rooms, which could not fully meet our needs. To accommodate the Finance Team, we set up an additional room. With the generosity of our landlord, we were able to rent another room, located directly opposite our office on the same floor on January 16, 2025 to serve as a 'Store room and Staff Lounge'.

We now have a Meeting Room, Director's Room, Finance Room, Staff Lounge and Store Room. If our budget permits, we plan to set up an additional room for the guest reception area in the future.

## Finance Report 2024-2025

#### INCOME (+)

**Preface :** Before proceeding, let us take a moment to clarify the following points to ensure a better understanding of the report.

- General Donation : A contribution that is not designated for any specific purpose but is given with the intent that it may be used wherever it is most needed is called 'General Donation' and are typically received via cash or bank transfer. It is important to note that this category does not include donated assets or tools, which are recorded separately.
- 2. Specific Donation : Sone donors chose to extend their generosity by supporting individual beneficiaries; whether patients or specific aid efforts. These contributions were carefully documented and directed to the intended recipients. These targeted contributions are called 'Specific Donations'.
- 3. Funds for Administration : Financial support for administrative functions is crucial to ensuring the smooth and effective operation of our foundation. Contribution received specifically to sustain these essential functions are classified as '*Funds for Administration*'.

These contributions are utilized to support essential operational needs such as transportation costs (including fuel), the purchase of office supplies and files, monthly staff remuneration and other necessary functions required for the efficient running of the office.

#### **DIFFERENCE BETWEEN PROGRAM & PROJECT**

Zo Inspiration Foundation has two major areas of expenditure, which are outlined below:

**1.Project:** This is a one-time project and is not intended to be ongoing or repeated annually.

**2.Program:** These are activities we consistently carry out each year, as well as activities initiated in one year that have the potential to be continued or followed up in the next.

#### EXPENDITURES OF VARIOUS PROGRAMS AND PROJECTS

#### **1. Charity Program (CP)**

This program stands as one of our most significant initiatives, dedicated to seeking charitable assistance for patients registered with us who are facing financial difficulties.

According to last year's records, the lowest charity plea for aid was made for Mr.C. Zirliana on May 5, 2024, amounting to ₹2,04,608/-, while the largest donation received was for Emy Lalremruati on September 17, 2024, totaling to **₹11,58,994/-** (Eleven Lakhs Fifty-eight Thousand Nine Hundred and Ninety-nine).

During the year 2024-2025, we made 14 appeals for aid and donations, which collectively amounted to **₹89,28,102/- (Eighty-nine Lakhs Twenty-eight Thousand One Hundred and Two),** we are deeply grateful for it.

The donations received were utilized by the intended beneficiaries. While some have already made full use of the funds, others have not yet done so. In some cases, for added convenience, funds were deposited into the beneficiaries' bank accounts as fixed deposits.

#### 2. Free Education Program (FEP)

This program was initiated to support children who lack the financial means to attend school. So far, we have used ₹33,330/- (Thirty-three Thousand Three Hundred and Thirty) to cover admission fees and purchase essential school supplies for the children enrolled in the program. Additionally, ₹14,510/- (Fourteen Thousand Five Hundred and Ten) has been spent on monthly school fees. For the 2025 - 2026 Academic Year, we have already begun supporting 50 children through this program.

#### 3. Shelter of Love Program (SLP)

Under this program, in the past year, we have built one (1) house and renovated two (2) others.

An amount of ₹3,32,813/- (Three Lakh Thirty-two Thousand Eight Hundred and Thirteen) from a donation received was allocated to support the renovation of Mrs.Phirneihmawii's house in Tuirial. Donations totaling ₹1,09,740/- (One Lakh Nine Thousand Seven Hundred and Fourty) were received from generous donors to support the house renovations of Mrs.Lalawmawii, Thingsulthliah and Mrs.Kawllianveli, Rangvamual.

The total expenditure for the house renovations for these widows amounted to ₹4,42,553/- (Four Lakh Fourty-two Thousand Five Hundred and Fifty-three). Our most recent initiative was the renovation for Mrs.Kawllianveli, which was completed on January 27,2025.

When we build homes, the support we receive comes through donations in the form of money, materials or tools generously given by kind-hearted and earnest individuals by God's grace. Thanks to these contributions, our actual spending is often lower than the estimated costs, helping us significantly reduce overall expenses.

At times, we receive building materials such as cement, soil, stones, bricks and water as donations. In addition to these, we also receive valuable support from the local community, including YMAs, VCs other NGOs; free of cost. This collective support greatly helps in reducing our overall expenditure.

#### 5. Food For The Poor Project (FFTP)

This program was initiated across various villages in Mizoram to support individuals in greater need by providing rice and financial assistance to help them care for themselves. To initiate this project, we received a generous donation of ₹74,800/- (Seventy-four Thousand and Eight Hundred) from Mrs.Lalfakzuali from USA. From this amount, ₹15,800/- (Fifteen Thousand and Eight Hundred) was spent on vehicle hiring, lodging and food for the team involved in the distribution. The total expenditure for purchasing 30 bags of rice and providing financial support was ₹59,000/- (Fifty-nine Thousand).

In addition, some of the beneficiaries did not have bank accounts, so we assisted in opening accounts on their behalf. A few accounts are still being opened as of this report. For that reason, the donations are temporarily held in the foundation's bank account, making the balance appear higher until they are distributed to the intended beneficiaries.

All donations for those in need are systematically managed and recorded in our office cashbook, tracking every inflow and outflow.

## Foundation Programs



We often receive many requests for assistance through visits, calls/messages, and sometimes, due to the volume, we are unable to respond to every need. While we strive to assist based on the reports we receive, some forms of aid require significant funding, so we cannot always support everyone as intended. This program aims to address these challenges more effectively and sustainably.

After carefully reviewing their story in detail, we extend our support based on their specific hardship and needs, either through financial assistance or in kind. In some cases, we provide help through their village YMAs. Some individuals may need support but cannot responsibly manage cash. In such cases, we provide assistance in kind by purchasing the items they need. At times, we also help by covering their hospital bills when they are admitted for treatment.

When individuals visit our office seeking assistance and are either deemed reliable or no other challenges persist from our side, we try to provide a small amount of money to take home, if possible.



During 2024 - 2025, we made 14 donation appeals through this program and the total amount of donations received was **₹89,28,102/- (Eighty-nine Lakhs Twenty**eight Thousand One Hundred and Two).

We appeal for donations on behalf of those who came to us facing severe illness or life-threatening situations and are in urgent need of help. However, we also make donation appeals for patients or individuals in need when the public seeks our involvement and wishes to offer support through us.

Our process starts with a thorough review of their income, family situation, number of able workers, financial condition and other key details. We also reach out to their local/village YMAs/YLAs and VCs for verification. Under this initiative, we prioritize patients with a chance of survival and extend special support to children and youth who still have their lives ahead of them. However, we have also extended support to the elderly, depending on the nature of their situation and needs.

Usually, our donation appeals run for three days. After the appeal period ends, the Finance Team prints the foundation's bank statement for that specific timeframe. Any donations received in cash or through other channels are added to the total, and all amounts are verified using a '**Maker Checker System'.** 

Given the need for careful handling of funds, only the finance Team is allowed to manage the money, unless there is a specific and important reason for others to be involved.



This program began in April 2024, initially focusing on supporting orphans and children of widows under the age of 10 who were facing hardship. However, starting from this 2025–2026 academic year, we have expanded our scope to include children above 10 years old as well.

We initially began by sponsoring 26 children from different parts of Mizoram. At the beginning of the academic year, we provided them with school uniforms, bags, notebooks, and pencils. We also provided their monthly school fees directly to the school authorities.

For the new academic session of 2024–2025, we are making preparations to sponsor 50 children. By the time this report was being prepared, most of these children had already been successfully admitted to their respective schools.

On April 15, 2025, we signed an agreement with Home Mission School, Zemabawk. They agreed to accommodate 7 children in their hostel free of charge, while we will continue to provide for the children's needs, much like a parent.

This initiative has borne wonderful fruit, thanks to God's blessings. Our children have achieved excellent results, often ranking among the top 10, which inspires us to take on even greater challenges.

When we launched this program, there was no dedicated funding. We started by using leftover donations initially given in 2023 for Lalvenhima (L), a child abandoned by his parents following his passing.

Generous donors have also come forward to sponsor children through this program, which has helped reduce our load in many ways and made it much easier to carry out this important work.



Through this program, we build homes for those in need, made possible by the generous donations we receive for such causes. During 2024–2025, with the support of our donors, we successfully built three homes in Thingsulthliah, Tuirial and Rangvamual.

Since the establishment of the Foundation, a total of 19 houses have been constructed under this program. These homes have been allocated to beneficiaries including widows and individuals experiencing homelessness.

As building a house is an arduous task, it cannot be completed by our team alone. So, we collaborate with the YMAs, VCs and other NGOs. We also receive valuable voluntary support from groups of close friends. Acquiring land is often one of the most difficult steps in the housing process. When beneficiaries do not possess land to build on, we coordinate with the VCs to submit for a formal request for land allocation.

When constructing a house, we typically build with dimensions of 24ft x 16ft, and to ensure the columns are stable, we use cement. The floors are made of wood, while the walls are covered with tiles. The roofs and the skirting are made of steel sheets. The bathroom floors are finished with cement, and the skirting there is made of bricks. We put carpets on all floors and paint both the interior and exterior of the houses.

Depending on their residential areas, we install wall fans. For those living in villages, we also build a separate fireplace for the kitchen area.



Ever since the foundation was established in 2020, it has been our annual tradition to host a Christmas Charity Program at the end of each year. During this time, we visit families facing financial hardship and extend our support - whether through monetary aid or gifts in kind - so they can experience the joy of the festive season without added stress or emotional burden.

Even in 2024, we held the Christmas Charity Program from November 28 to December 28. The following are the projects that were carried out under the program last year:

- a. Charity Ride in Village and Remote Areas
- b. Midnight Meals Project
- c. Teddy Bear & Toys for Kids
- d. Charity Ride in Mission Areas
- e. Christmas Card Distribution

Along with our board members, advisors, executive members and volunteers, we

go out into the community to carry out this program. Each year, while we offer help to those in need, we also find a deep sense of fulfillment ourselves.

One of the most touching initiatives from last year's program was the 'Midnight Meals Project'. Around midnight, we went out to the streets and quiet corners of the city to distribute meals to those who felt forgotten and unloved - people who believed no one cared for them.

We also spoke with many young people struggling with drug addiction. We provided them with essential medication, and our volunteer doctors were present to conduct basic health check-ups.

What people truly crave are listeners, not advisors, and to become the kind of person others feel safe to share their struggles with, we live with humility and tranquility. This insight has been one of the most valuable lessons we have learned.



This initiative was launched to help struggling families establish a stable and sustainable source of income. Priority is given to widows, orphans, fatherless households, and families facing significant financial hardship.

With our support, some beneficiaries have successfully started small businesses, such as variety stores, while we have provided others with seed capital to establish their own sources of income.

With careful consideration of how individuals can best utilize their skills, we have, in some instances, provided a sewing machine and in others, facilitated the provision of a two-wheeler taxi. For beneficiaries interested in pig rearing, we would provide support by supplying piglets and constructing pig pens to help them initiate their livelihood activities. As a gesture of appreciation, some of them shared a portion of their produce with the team.

Alongside pig rearing, we have supported in poultry farming by providing broiler chicks and arranging for craftsmen to construct chicken coop beneath their homes. While some saw notable profits from this initiative, others faced challenges due to outbreaks of avian flu.

Overall, we believe the program has, on average, been profitable for all involved, and we plan to continue it through this new 2025–2026 year.

## Success Stories

## Brain Cancer



**EMY LALREMRUATI** Ben ID : CP-09-24-084

Emy Lalremruati was born on March 16, 2018, as the third child of Mr. H. Malsawmkima and Mrs. Lalthanzuali. Following her parents' divorce in May 2024, she and her siblings have been living with their father. They previously resided at Lawipu, BSUP. In 2020, the family relocated to Dinthar Veng, Thenzawl. They are currently living in a rented basement room for ₹1,000, together with her father. Mr. Malsawma works in construction, taking on various jobs as the need arises.

## How her illness began:

Emy began experiencing difficulties withbowel movement at two and a half years old. Initially, doctors suspected a bowel disorder. However, her condition gradually worsened. By 2024, her health had significantly deteriorated, leading to her admission to ZMC, Falkawn, in May due to complications related to bowel function.

After a 10-day hospital stay, Emy was discharged with a follow-up appointment scheduled for one month later. However, soon after leaving the hospital, her abdominal pain intensified, accompanied by headaches, vomiting and body swelling. On July 16, 2024, she was readmitted to ZMC. Further tests, including **Brain MRI**, revealed she had a tumor in her brain. Doctors advised that without prompt surgery at NEIGRIHMS Hospital in Shillong, Emy's chances of survival would be very low. Perplexedly, Emy's stomach would become bloated, though it remains unclear whether this symptom is related to her brain tumor.

## How our paths crossed:

In July 2024, our Founder and Staff visited ZMC to meet with patients, including Emy. They offered to take initiative to help Mr. H. Malsawmkima after they heard about their hardships and family circumstances. However, he graciously declined the offer, stating that there may be others in greater need of support.

But after three heartfelt conversations and with no improvement in his daughter's condition, he finally agreed to accept the support. For Emv's sake, a donation appeal was made on August 1, 2024 and a total of Rs. 7,01,885/- (Seven Lakhs **One Thousand Eight Hundred** and Eighty-Five) was raised and handed over to the family on August 9, 2024 at NEIGHRIHMS Hospital, Shillong.

Emy's condition was so critical that

the initial donation was not enough to cover her treatment. Contrary to how we previously operated, a second appeal was made on September 1, 2024. This time, a significant donation amounting to ₹ 10,14,220/- (Ten Lakhs Fourteen Thousand and Two Hundred and Twenty) was raised and handed over by the Director on September 18, 2024 at Medica Superspeciality Hospital, Kolkata.

## From Shillong to Kolkata:

On July 28, 2024, Emy and her father visited NEIGRIHMS in Shillong, where doctors began an investigation to determine whether she could undergo surgery. As part of the evaluation, a biopsy was performed. On August 23, 2024, the results confirmed that Emy had been diagnosed with brain cancer.

As Emy's tumor continued to grow, it began to significantly affect her body. However, the surgery schedule at NEIGRIHMS was still too far away to address the urgency of her condition. Given the circumstances, on August 28, 2024, we made a trip to Medica Superspeciality Hospital, Kolkata in search of faster and more urgent medical attention.

At Medica Superspecility Hospital in Kolkata, Dr. Harsh Jain, a neurosurgeon, performed emergency surgery on Emy on August 30, 2024. Following the operation, she was placed in a medical induced coma for seven days to aid recovery and remained in the ICU for a significant period. After a month, she was finally discharged from the hospital.

They were advised to have a checkup on December 16, 2024, so they rented a place in Kolkata, doing their best to manage. The cancerous brain tumor in Emy's brain was located right at the center and unfortunately, the disease had already spread to other areas, making it impossible to remove everything at once. When they went for the check-up on December 16, they learned that the remaining part of the tumor had grown. After completing a three-month treatment course by May 2025, they'll return for another check-up and a brain MRI.

## Coming Back to Mizoram:

After completing her radiation treatment course, Emy and her father finally returned home, landing at Lengpui Airport on February 12, 2025. It was a joyful homecoming. We had spent 185 days away, dedicating that time to her recovery.

They returned to their home in Thenzawl to continue Emy's care in a more familiar and supportive environment. While there, she received therapy at Ayush Hospital, Thenzawl. On March 28, 2025, she completed the first phase of her treatment.

After Emy's surgery, she struggled with memory loss and paralysis on her right side. It was a difficult and uncertain time for all of us. But slowly, thankfully, her memory began to return. Bit by bit, she started regaining movement in her body, giving us hope with every small step forward.

The doctors had feared she would not survive the brain cancer. Throughout the long and arduous surgery that lasted for hours, we clung to hope and prayed desperately to God for her to wake up. Just when hope was nearly lost, she moved her hands and regained consciousness. It was a miracle, a powerful reminder that even the impossible can be overcome. Praise the Lord.

## **Heart Defect**



## **CICILYA LALTLEIPUII** Ben ID : CP-12-24-087

Cicilya Laltleipuii was born on December 29, 2018, as the firstborn of the three children to Mr. Rosiama and Mrs. Lalengmawii. Her birth took place at their home in Dilzawl village, where, due to the lack of medical facilities in the village, her delivery was a home birth.

## How her illness began:

At six months old, while being bathed by her mother, she suddenly experienced a seizure. Her body, including her hands and feet, turned blue, prompting her family to rush her to the nearest hospital for urgent medical attention.

Following a series of a medical investigations, doctors diagnosed her with a congenital heart defect, commonly known as a hole in the heart, present since birth. The family was advised to seek further treatment at a more advanced medical facility as soon as possible. However, due to various challenges and constraints, they were unable to do so and instead provided the best care they could at home

However, her condition gradually worsened, the tips of her fingers and toes began turning blue and her body grew increasingly weak. She also developed a strong sensitivity to noise. Episodes of vertigo caused her to lose balance and fall and she remained constantly fatigued and physically weak.

## How our paths crossed:

In November 2024, Cicilya's mother, Mrs. Lalengmawii, came across our initiatives and programs on Facebook and filled with hope, contacted our office. At that time, however, we were actively engaged in preparations for our Christmas Charity Programme and therefore unable to take on the case immediately.

After the program rush subsided, we took the opportunity between Christmas and New Year to thoroughly assess their situation. Recognizing the urgency, we issued a call for donations on December 20, 2024. We raised 8,55,167/- (Eight Lakhs Fifty-Five Thousand One Hundred and Sixty-seven) to support her treatment. On December 30. 2024, we handed over the money to them by reaching their village on vehicle and boat.

## Journey to Kolkata:

On January 17,2025, as previously scheduled, she departed from Lengpui Airport for RN Tagore Hospital, Kolkata, accompanied by her mother and Nurse Vivian Hmingthanmawii. The surgery procedure began on January 28, 2025 beginning at 8:00 a.m. and lasting approximately for five hours. She was subsequently brought out of the operating theatre at around 1:30 p.m. that afternoon. By the grace of God and through the prayers and support of many, the operation was carried our successfully.

On February 3, 2025, seven days after her surgery, she was discharged from the hospital. Her condition had shown improvement and she appeared more energetic.

They remained in Kolkata for followup medical checkups. During their stay, we were truly grateful to Lalmalsawmtluangi, the owner of Kolkata Mizo Thlen In Homestay, for her warm welcome and generous hospitality.

After attending to various important matters, they returned home to Mizoram on March 20, 2025 and arrived safely at Lengpui Airport. A thanksgiving prayer was held in our office to express our sincere gratitude to God for His guidance.

A child who was once teetering on the edge of life is now laughing with pure joy, running freely and playing happily with other children. We sincerely thank everyone whose donations and prayers made this possible.

# Femoral bone cancer



## LALRUATPUIA Ben ID : CP-06-24-080

Lalruatpuia was born on February 3, 2016, in Haiheng, Myanmar, to Mr. Krawschhuangzela and Mrs. Bawihnemi. He is the third child among five siblings. When he was just twelve months old, the family migrated from Myanmar and settled in Tiau Khawmawi, where they have since made their home and now reside permanently.

## How his illness began:

In December 2023, Ruatpuia began experiencing pain in his left thigh, just above the knee. As the pain worsened and noticeable swelling developed, his family sought help from a local chiropractor. As the treatment provided no relief, an X-ray was performed and the doctor advised that he be taken to Aizawl as soon as possible. After borrowing financial support from others, the family managed to travel to Aizawl on March 5, 2024.

### It was Cancer:

Upon arriving in Aizawl, an MRI was conducted immediately. Unfortunately, the results revealed that Ruatpuia was suffering from femoral bone cancer. The doctors advised that in order to prevent the disease from spreading further, an amputation would be necessary. On June 10, 2024, his left leg was amputated at Zoram Medical College in Falkawn. The surgery was considered successful and he

soon began undergoing regular chemotherapy sessions. As a result of the treatment, he experienced rapid hair loss, a common side effect of chemotherapy. He was unable to eat properly for an extended period as the illness gradually worsened. The family is now waiting for his medical check-up.

The family was going through a very difficult financial situation because both of his parents worked as laborers and earned limited income. They were deeply distressed by their inability to afford the medical care their son urgently needed.

## Support Campaign for Ruatpuia:

We continued to learn more about his condition and circumstances from people who shared his story. In response to our public appeal for support, a total of ₹4,20,550/-(Four Lakhs Twenty Thousand Five Hundred and Fifty) was generously contributed through donations. On June 26, 2025, we personally handed over the donation to him and his family in their village. On the same day, we also presented a wheelchair, graciously donated by a kind-hearted, anonymous donor.

As we prepare this report, the cancer affecting Ruatpuia is subsiding. He has been able to receive the essential medical attention he needs, made possible by the generous contributions of donors.

Even though he has lost one leg, he still stands strong on the other. With a crutch in hand, he continues to do the things he enjoys. He may be just a child but he has the mindset of an adult. With his faith in God, he keeps fighting the illness that still remains in his body.

Some live with pain, while others feel lifeless even while living. Ruatpuia is the kind who endures pain in his body, yet his mind remains joyful and his bright, cheerful face is a joy to see.

His family, who have cared for him with unwavering dedication and without a single complaint, are truly deserving of praise.

## Bone Marrow Transplant



## ANNIE LALNGAIHSAKI

Annie Lalngaihsaki was born on December 15, 2016, as the third child among four siblings to Mr. Lalbiakliana (L) and Mrs. Zorinpuii. Regrettably, her father passed away due to hyperpyrexia on January 2, 2020 and her mother has since remarried. Subsequently, Annie and her two elder siblings are now being cared for by their paternal uncle, Mr. Zobuaithanga and are now currently residing in Vathuampui, Lawngtlai. Success Story

## How her illness began:

In September 2023, Annie experienced vomiting accompanied by fever, stomach pain and body ache. She was taken to Christian Hospital, Lawngtlai, where she was diagnosed with typhoid and admitted immediately. After receiving proper medical care, she was discharged from the hospital.

Although her family hoped and believed she would recover with time, Annie fell ill again in November 2023 with the same symptoms as before. Due to financial difficulties, they were only able to travel to Lawngtlai on December 12, 2023. Upon arrival, as there were no available beds at Lawngtlai Civil Hospital, she was once again admitted to Christian Hospital, where she was diagnosed with typhoid and received appropriate treatment.

However, despite completing the full course of treatment, there was no sign of improvement in her condition. When a lump was found near her ear, she was referred to Christian Hospital, Serkawn, for further examination and care.

After staying at Christian Hospital, Serkawn for two days, she was referred to Zoram Medical College, Falkawn, as the facility was unable to carry out a biopsy.

On May 16, 2024 at 1:45 a.m, medical investigation commenced at Zoram Medical College, Falkawn. Based on the biopsy result, it was concluded that Annie would need a bone marrow transplant. The estimated cost of the procedure was at least ₹ 10,00,000/- (Ten Lakhs).

## How our paths crossed:

Understanding their difficult circumstances, the doctors and nurses felt deep empathy for the family and reached out to Zo Inspiration Foundation for assistance. We visited them at Zoram Medical College, Falkawn on November 7, 2024. They had only ₹10 at the time, so we provided funds for their immediate needs. On the next day, i.e. November 8, 2024, we began a fundraising campaign for them.

Our fundraising campaign for Annie Lalangaihsaki raised a total of ₹6,61,227/- (Six Lakhs Sixtyone Thousand Two Hundred and Twenty-seven) which was made possible by the generosity of our donors. The donation was handed over to them on November 18, 2024 at ZMC, Falkawn.

## Going forward with Hope:

We were disheartened as the funds we have raised for Annie's bone marrow transplant was insufficient to cover the surgery. However, seeing the genuine happiness on Annie's and her uncle's face gave us strength and boosted our spirit.

We found it profoundly moving when they said "The Lord has always provided us with what we need; this is not a futile effort". We consider this initiative a success, even if the bone marrow transplant cannot take place at this time. Annie is receiving essential ongoing medical care thanks to the generosity of the donors, even while this report is being prepared.

## She was discharged:

As Annie has a deep love for drawing, her uncle supported her by buying her art supplies and she continues to draw despite her illness. By God's grace, she has since been discharged and is now feeling better and doing well. Her most recent check-up included a D-Dimer test and we are currently awaiting the results.

By the time you read this report, we believe that Annie will be well and in good health. We humbly ask that you keep her in your thoughts and prayers, even if only once.

## Landslide Accident



## CLAIRE ZOREMMAWII

Claire Zoremmawii, the middle child of three siblings was born to Mr. F. Lalchawimawia and the late Mrs. Baby Zoremsiami on September 30, 2018. In 2024, Claire and her siblings enrolled at Dinthar Primary School, where their mother had also served as an SEDP Teacher.

## The family was caught in an accident:

The family lived in Melthum, but on May 28, 2024, the relentless heavy rainfall triggered a devastating landslide that swept away their home with the entire family inside. Tragically, six of Claire's family members lost their lives in the disaster and she was the sole survivor.

At the time of the devastating disaster, Claire's father, Mr. Lalchawimawia was away from home due to work commitments. Tragically, Claire's mother, Mrs. Baby Zoremsiami and her siblings lost their lives at the scene. Claire and her father are now the only surviving members of their immediate family. They currently live with her paternal grandparents at Zonuam.

Claire sustained severe injuries in the disaster, including fractures in her right arm and leg, torn skin on her back, a split ear and several cuts and bruises on her face. After a long and difficult search, volunteers eventually found Claire amidst the landslide. Remarkably, she was sitting quietly between the rocks, not shedding a single tear.

And then, Claire was taken to Trinity Hospital for immediate medical attention, but on May 28, 2024, she was transferred to the Ortho Ward at Civil Hospital, Aizawl due to conveniences. She was under the dedicated care of orthopedic specialist Dr. Manghaka. By God's grace, Claire has shown significant improvement.

## How our paths crossed:

We became aware of Claire's family's situation through social media, and following this, our founder visited Aizawl Civil Hospital on the night of May 20,2024, to provide assistance and deliver initial aid.

The public responded with compassion upon hearing about Claire's family's circumstances. In response, and for Claire's sake, we opened a donation period; a total of ₹ 4,15,597/- (Four Lakhs Fifteen Thousand Five Hundred and Ninety-seven) was raised. On June 3, 2024, the collected amount was officially handed over to the family.

## Discharged from the hospital:

On June 24, 2024, Claire was discharged from the hospital with a stable condition. However, her leg was still in a cast and had not yet been unwrapped. It was not until July 18, 2024, that the cast was finally removed. It was discovered that Claire had sustained a head injury that impacted her brain, which could potentially lead to memory-related issues. Following the doctor's advice, she was referred to Psychiatric Hospital in Kulikawn for 'Memory Recalling Counselling'. She attended one session and was scheduled to return a year later, as she was still quite young at the time. In the meantime, her family supported her by engaging her in various mental exercises to help strengthen her memory.

On the night of January 30, 2025, some of our board members visited Claire. It was heartening to see her looking healthy and well. In addition to the dedicated care from her father, her grandparents have also played a significant role in her recovery and we are truly grateful for their efforts.

## She can go to school:

Due to the severe injuries she sustained in the accident, Claire was unable to attend school during the 2024 academic session. However, we are pleased to share that she is now being admitted to KG - II at Divine Intervention School for 2025 session.

At the time of preparing this report, Claire has not yet taken any examinations. We receive updates on her progress through her grandfather and we sincerely wish her continued growth and that she blossoms into a kind and admirable young lady.

## Orphan Siblings from Ruantlang



Mr. Lainisanga's children formerly resided in Ruantlang, Champhai. Following the passing of their father, the Zo Inspiration Foundation relocated them to Aizawl and has since been providing care and support to the extent of our available resources.

## Details of their family history:

The late Mr. Lainisanga was born in 1970. He was one of ten siblings, though one had sadly passed away. Three of his siblings currently reside in Mizoram, while the rest live in Myanmar. He was originally from Tikhuangtum village in Thantlang District, Myanmar. Mr. Lainisanga and his entire family moved to Tahan when he was five years old. Both of his parents have since passed away.

The family migrated from Myanmar to Ruantlang, Champhai in 2006. In 2007, Mr. Lainisanga married Mrs. Vanlalpeki of Ruantlang, and they were blessed with five children. However, in February 2022, Mrs. Vanlalpeki departed and began a new life with another partner. She has since remarried, had additional children with her new husband and now resides in Darlawn.

The children have mentioned that they occasionally maintain contact with her by phone. At the time Mrs. Vanlalpeki left her husband and children, their eldest child was only 15 years of age while the youngest child was only 6 years of age.

## The mother left, the father got sick: After their mother left, it was discovered

After their mother left, it was discovered in 2012 that the late Mr. Lainisanga had been diagnosed with Hepatitis C. Due to severe financial difficulties, he was unable to seek hospital treatment at the time. In 2019, when his health deteriorated and was bedridden, the Ruantlang Branch YMA kindly stepped in and took him to the hospital. There, he was diagnosed with tuberculosis (TB). With limited resources, he continued his treatment at home, relying on TB medication and the care they could manage on their own.

However, in 2023, just before Christmas, his condition worsened significantly. He became too weak to even prepare his own meals and his stomach became swollen and bloated. He was also suffering from stomach ulcer, which caused him great discomfort and made it difficult for him to sleep at night.

## Leaving Behind His Children:

As their father was too ill to work, the responsibility of supporting the family fell on the siblings. They took up work as cow herders, a demanding job that offered no days off, not even on Sundays, making it impossible for the siblings to attend church. With herding cattle as the family's only source of income, they were unable to attend school, despite their sincere desire to pursue an education.

While the children were occupied with the heavy responsibility of providing for the family, Mr. Lainisanga's health steadily deteriorated. With deep sorrow, it is remembered that on the morning of January 17, 2024 at 6:00 a.m., the late Mr. Lainisanga peacefully passed away, leaving behind his five beloved children.

Upon learning of their circumstances, various NGOs and churches in Ruantlang village extended their support by providing financial assistance and meals to the family, offering help to the best of their abilities. In Addition, numerous individuals and community groups also contributed generously to support their needs.

### Our Aid and Outreach Efforts:

The then-Secretary of Ruantlang Village YMA reached out to our Founder to share the story of the siblings. After a careful review and thorough assessment of their situation, we concluded that it was necessary to take meaningful action on their behalf. Consequently, on January 12, 2024, we made a public appeal for assistance.

On January 30, 2024, we delivered the *₹4,75,610 (Four Lakhs Seventy-five Thousand Six Hundred and Ten)* raised from the public appeal directly to their home in the village.

At that time, some of their relatives from a neighboring village were staying with them temporarily. However, when it became evident that their relatives could not remain with them indefinitely, we grew increasingly concerned. This led to several discussions and coordination with the YMAs.

## Reconstructing their Home:

The house where they had lived while their father was alive had fallen into disrepair and was no longer suitable, especially with the rainy season approaching. Therefore, on February 8, 2024, we began rebuilding the house in collaboration with the YMAs. After a week of dedicated work, the Pastor of Ruantlang, Rev. K. Lalthlamuana, held a blessing ceremony to dedicate the new home to God.

As time went on, the person who was supposed to stay with the siblings was no longer available, so we had to reconsider our plans. After much thought and discussion, we decided it would be best to bring them to Aizawl and arrange for them to stay in hostels. We felt this was the safest option, as leaving them alone in the village could expose them to risks and potential harm.

We searched thoroughly for schools where the siblings could be enrolled and eventually, we got in touch with the Principal of Divine Intervention School at Zonuam. He welcomed us warmly and wholeheartedly promised to help. With his support, we decided to enroll the children in the school's hostel. This plan was also agreed upon by Ruantlang YMA. Though they deeply wished to continue caring for the siblings, they entrusted them into our care.

## From Ruantlang to Aizawl:

On April 8, 2024, we transported the siblings from their hometown to Aizawl using two vehicles. Prior to our departure, we visited their father's grave to pay our respects. The journey proved to be quite challenging, as the children suffered from severe motion sickness and became repeatedly ill, requiring us to travel at a slower pace. As the accompanying team consisted entirely of male members. we encountered some limitations in providing the level of personal care the situation required. Nonetheless, every effort was made to ensure their wellbeing and comfort throughout the trip.

We arrived in Aizawl at around 8:30 p.m. After having dinner at our office in Ramhlun Venglai, we chose to spend the night there rather than relocate to another place. The children were visibly exhausted from the long journey and soon fell into a deep, peaceful sleep. While they appeared physically at ease, we could sense an underlying feeling of homesickness beginning to set in.

On the morning of April 10, 2024, we purchased essential items for the children, including new clothing, as the ones they had were no longer in good condition. Later that afternoon, we admitted them to the hostel at Divine

Intervention School, saying goodbye with hope, yet also with tears in our eyes as we headed back home.

The siblings share a deep and abiding love for one another. Before his passing, their late father entrusted the eldest with the heartfelt responsibility of ensuring they always remain together. In honoring this wish, and recognizing that separating them would not be in their best interest, we respectfully requested the principal to allow the eldest sibling to serve as a helper in the school kitchen. This arrangement allowed him to work within the school premises, ensuring his younger siblings could remain close to him throughout the day.

## We visited them:

We would visit the children on Hostel Visiting Day, which takes place on the second Saturday of every month. During our visits, we would bring them food and other essential items they might need for school. Additionally, we would use this opportunity to pay their monthly fees, as well as clear any outstanding debts they might have.

Knowing that we would be visiting them, the children would eagerly look forward to our arrival. Prior to each Visiting Day, they would call us using their teachers' phones to share their needs and inform us of any items or support they might require.

As 'Visiting Day' is the only time we can see the children, we would use the time to speak with their teachers about their academic progress and overall well-being. The teachers would keep us informed, sharing both positive developments and concerns regarding the children.

## **Visible Progression:**

Initially, everything was new and unfamiliar, so there was little progress to observe. However, after three months, we began to see noticeable changes in their performance. Although our children still have a long way to go compared to others, they have shown steady improvement and made commendable progress in all areas.

The middle child even won a prize in the Mizo speaking competition at school, and all of them began to show improvement in their examination results. While there have been moments of joy and encouragement, there have also been difficult and trying times - moments that felt discouraging and uncertain. However, these challenges are not reasons to lose hope or give up on them. Though we do not know what the future holds, we are committed to supporting and caring for them until they reach adulthood.

The difficulties they initially faced with the English language have gradually become less challenging. Their manners have also improved significantly — they are now more polite, well-behaved, and increasingly aware of what is appropriate and inappropriate. Their overall conduct has shown marked improvement.

We heard their testimonies and the progress made through our initiatives, gaining important insights for follow-up. The event was filled with joyful moments and proved to be truly enriching.



## **4** New office inauguration ceremony

On October 5,2024, a blessing ceremony for our new office was held at Lalthuama Building, Chanmari, Aizawl to dedicate the office to God. The ceremony was led by Rev. B. Sangthanga, Ramhlun North who offered prayers to God for His guidance and protection.

On September 17, 2024, we visited again and with the acknowledgment of the village NGOs, we were able to relocate them to TNT in Aizawl.



On May 17, 2024, we visited our Advisor Mr. K. Lalhmingmawia, who had been admitted to Ebenezer Hospital due to cancer. By the grace of the Lord, he is now recovering well and we are truly thankful for his improved health.



On August 13, 2024, we held the opening ceremony for the house built for the widow Mrs. Neihmawii, Tuirial, made possible through the generous contributions of our kind sponsors. Construction began on July 22, 2024 and we are deeply grateful for the invaluable support from the YMAs and many selfless individuals.



On September 17, 2024, we visited the Mission Field in Hnahva village where we had the opportunity to distribute clothes and medicine to the non-Mizo residents living in the area.
